**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE
BID (LCRB)**

WHEREAS, the Tarlac State University advertised the Invitation to Bid for the project Supply and Delivery of College Uniforms, Rebid, with an Approved Budget for the Contract (ABC) of ₱ 5,425,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on August 31, 2022;

WHEREAS, in response to the Invitation to Bid, two (2) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) on September 8, 2022;

WHEREAS, in the public bidding held at the TSU-BC AVR on September 20, 2022, at 2:00 P.M.:

- (a) two (2) bidders, namely, Zhujar Manufacturing, Inc., and Woman Fine Clothing, Inc. tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bids of the two bidders and found the bids to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and were rated "passed",
- (c) the BAC evaluated and ranked the financial bids of the two bidders,
- (d) the BAC resolved to declare Zhujar Manufacturing Inc., as the bidder with the Lowest Calculated Bid for Lot 3 with the bid price of ₱ 2,698,000.00,
- (e) the BAC resolved to declare a Failure of Bidding for Lot 2, since no bid was received for this lot,
- (f) the BAC resolved to recommend to the Head of the Procuring Entity the procurement of Lot 2 through Negotiated Procurement, as prescribed in Section 35.5 of the Implementing Rules and Regulations of R. A. 9184, and
- (g) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the LCB;

WHEREAS, in the Post-Qualification Evaluation Conference held on November 8, 2022:

- (a) the TWG for the Financial and Legal Aspects reported that the bid of Zhujar Manufacturing Inc., was responsive to the legal and financial requirements for the project,
- (b) the TWG for Technical Aspect reported that the bid of Zhujar Manufacturing Inc., was responsive to the technical requirements for the project, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the bid of Zhujar Manufacturing Inc., as responsive.

THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- (a) to declare Zhujar Manufacturing Inc., as the bidder with the Lowest Calculated and Responsive Bid (LCRB) for the project Supply and Delivery of College Uniforms, Rebid, Lot 3 with the bid price of ₱ 2,698,000.00 and
- (b) to recommend to the President the Award of Contract for the project Supply and Delivery of College Uniforms, Rebid Lot 3 to Zhujar Manufacturing Inc.


