CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of _____, 2025 between TARLAC STATE UNIVERSITY of Romulo Boulevard, San Vicente, Tarlac City (hereinafter called the "Entity") and PRIMARCH BUILDERS of Unit 7 Ten Bidg., Mac Arthur Highway San Rafael, Tarlac City (hereinafter called the "Contractor").

WHEREAS the Entity is desirous that the Contractor execute Expansion of Guard House with CCTV Control Room (hereinafter called "the Works") and the Entity has accepted the Bid for Five Million Four Hundred Forty-Eight Thousand Seven Hundred Ninety-Seven Pesos and Sixty-Five Centavos (Php 5,448,797.65) by the Contractor for the execution and completion of such Works and the remedying of any defects therein

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- The following documents as required by the 2016 revised implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional</u> <u>contract documents or information prescribed by the GPPB that are</u> <u>subsequently required for submission after the contract execution, such as</u> <u>the Notice to Proceed, Variation Orders, and Warranty Security, shall</u> <u>likewise form part of the Contract.</u>
- In consideration for the sum of Five Million Four Hundred Forty-Eight Theosand Seven Hundred Ninety-Seven Pesos and Sixty-Five Centavos (Php. 5,448,797.65) or such other sums as may be ascertained, Primarch Builders agrees with the project: Expansion of Guard House with CCTV Control Room in accordance with his/her/its Bid.

Expansion of Guard House with CCTV Control Room

- The Tarlac State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. This Agreement shall take effect upon date of confirmation of NOTICE TO PROCEED by the Contractor from the Entity. The Contract shall remain in force until all obligations of both parties as contained in this contract have been fully complied with
- 6. The Contractor shall commence execution of the project within ten (10) calendar days from the confirmation of written Notice to Proceed from the Entity and shall finish and complete the construction of the project within One Hundred Fifty (150) calendar days from the date of confirmation unless extended in accordance with the IRR of R.A. 9184.
